

City of Onalaska Urban Deer Hunt  
City Permit Policy (updated 8/16/10)

1. Persons desiring a City Permit to participate in an Urban Deer Hunt shall procure an application form, Urban Deer Application (UDA) from the Park and Recreation Dept, will include the following needed information:
  - a. Present Proficiency Score Sheet (Appendix B) completed by a representative of La Crosse Archery.
  - b. Presentation and copy of valid and current Wisconsin DNR Archery License.
  - c. Each City Urban Deer Application shall be subject to an administrative fee of Twenty Dollars (\$20.00); ten dollars (\$10 per test) of which will be paid for Proficiency testing @ the assigned location, La Crosse Archery, 1231 Oak Forest Dr. If the individual passes, said required testing will be waived for 5 years. During that time, if the individual wants to participate during those years, the twenty dollar (\$20) fee per season will stand and be totally payable to the city.
  - d. Review Rules and Shooting Safely & Ethically – Appendixes C and D respectively.
  - e. Individual must score 100% on Bowhunter Exam – Appendix E; then applicant will be eligible for participation.
  - f. The city will grant the applicant the DNR Nuisance Tags and associated back tags at that time.
  - g. City Permits are non-transferrable, non-refundable, and shall only authorize the named Permittee to participate in the Urban Deer Hunt pursuant to any restrictions contained therein during the season designated on the permit.
  - h. Notwithstanding any other provision contained herein, the Park and Recreation Department shall retain the absolute discretion to issue, deny, or revoke a City Permit, or to limit or condition the same in any manner, for any reason or no reason.
  - i. Only the areas shown and described on the Urban Deer Zone Map on the reverse side are open to the Urban Deer Hunt.
  - j. Please note that DNR personnel have the right to collect and hold any deer carcass or parts of carcasses that may show signs of diseases.
  - k. Hunting will begin the Wednesday following the last October gun season. Hunting will be prohibited during the November gun season and said closure extended thru all December firearm seasons. December hunting will open the Wednesday after said December firearm hunt and continue till January 31<sup>st</sup>.
  - l. Hunters must follow and abide by all standards and regulation set forth in the Management Plan and its appendixes.
  - m. All permitted hunters are responsible for any damage caused to others, themselves, and for property damage.
  - n. Persons who apply for a permit under 18 years of age shall have written permission from their parents or guardian.

## City of Onalaska Urban Deer Zones

All lands within the City of Onalaska municipal boundaries fall into:

**Zone 1:** Easterly at point of beginning found at the intersection of County Rd 01 and Sand Lake Rd following Sand Lake Rd to the intersection with US Highway 53. Then zone lays easterly of same US Highway 53 to the intersection with Main St and Main St E. Zone follows Main St E/County Rd 05 on the northerly side to the intersection with State Rd 16. Going east at same intersection, the zone lays on the northerly side of said State Rd 16 to the municipal limits towards West Salem.

**Zone 2:** All lands lying south of State Rd 16 at the extreme easterly boundary of City of Onalaska limits, east of the City of La Crosse limited city (county parcel area), and north of I-90. The easterly limit is the City of Onalaska and Township of Hamilton common border.

**Zone 3:** Starting at the Holiday Heights subdivision, all lands lying easterly & southerly of State Rd 16 to the intersection of S Kinney Coulees. Then East on S Kinney and all lands found south of S Kinney Coulees to the City of Onalaska limits abutting the Township of Hamilton.
