**Jul. 31**—2nd installment of Real Estate taxes due to the County Treasurer

### Real Estate Taxes:

- **Payments made through January 31, 2016** must be made to the Onalaska City Treasurer at 415 Main Street, Onalaska.
- Visa, MasterCard and Discover credit cards are now accepted **IN PERSON ONLY** with a 2% merchants fee charge 
- **Escrow checks** must be endorsed by all parties and will be applied in full to the tax bill. If refunds are applicable, a check will be issued within ten (10) business days.
- **Payments made after January 31, 2016** must be made to the La Crosse County Treasurer at 400 N. 4th Street, La Crosse. La Crosse County accepts cash, check and credit cards.

### Personal Property Tax:

- All personal property tax must be paid in full to the Onalaska City Treasurer **on or before January 31, 2016.**

### Christmas Trees:

Curbside pickup is available the week of January 12<sup>th</sup> - the same day as your regular refuse pick up day. 



### Yard Waste:

#### April - Nov.

The 2016 Yard Waste stickers will be available for purchase for \$20. The fee includes pick up for the months of May - Nov. (see 2016 Recycling Brochure for exact dates). Pickup of Yard Waste in April will be free of charge for all residents. ### Refuse & Recycling: (NOTE):

**Placement of Carts:**  
Summer: can be placed in street, but driveway or boulevard is preferred  
Winter: may be placed in street but your assistance is appreciated by placing in driveway or a cleared spot in boulevard area. Carts must be a minimum of 3 feet apart. 



### ANIMAL LICENSES

**REMEMBER TO SEND SELF - ADDRESSED STAMPED ENVELOPE FOR RETURN OF TAGS!!**



You will need to provide written documentation of proof of rabies.  
\*All dogs and cats over five (5) months old must be licensed.  
\*If your pet has not been previously licensed or has since been fixed, you must also provide proof of spay or neuter.

### CHANGE IN FEES

Spayed/Neutered—\$13.00  
Unaltered —\$23.00  
Late Fee (after 4/1)—\$25.00—Per animal  
\*\*Any dogs renewals after April 1, 2016 need to include the late fee and will be paid to La Crosse County Clerk's Office—400 N. 4th Street, La Crosse.
