

**WHEREAS** on March 8, 2016 the Common Council of the City of Onalaska approved and passed Preliminary Resolution 25-2016 to vacate and discontinue Main Street west of 2<sup>nd</sup> Avenue South / State Road 35 and the Court Street South alley between Main Street and Irvin Street in the City of Onalaska;

**AND, WHEREAS**, a notice of public hearing concerning said vacation and discontinuance was published and provided in accordance with Sec. 66.1003, Stats.;

**AND, WHEREAS**, a public hearing was held on April 19, 2016 at 7:00 p.m. regarding said vacation;

**AND, WHEREAS**, it appears that the public interest as it will enable the City of Onalaska and abutting property owners to better utilize the vacated land as part of the Great River Landing;

**NOW, THEREFORE BE IT RESOLVED**, that the Common Council of the City of Onalaska, La Crosse County, Wisconsin does hereby vacates Main Street west of 2<sup>nd</sup> Avenue South / State Road 35 and the Court Street South alley, which are more particularly described on Exhibit A which is attached hereto and incorporated herein.

**BE IT FURTHER RESOLVED**, that a certified copy of this Final Resolution together with a map showing the location of the vacated road shall be recorded in the Office of the Register of Deeds for La Crosse County, Wisconsin.
